

PWH-NDA-01
STANDARD NON-DISCLOSURE AGREEMENT
BETWEEN A PUBLICITY-SEEKING HEIRESS AND A SINGLE INDIVIDUAL
For multiple partners use form PWH-SLT-01

WHEREAS, Ms. Hilton and _____ (hereinafter “Partner”) wish to engage in consensual activity most likely of a sexual nature amongst and between themselves (Ms. Hilton and Partner collectively, hereinafter referred to as the “Parties”),

WHEREAS, the Parties wish to get it on, or attempt to get it on, by rounding some or all of the “bases” in any combination (“first” and/or “second” and/or “third”) or in whole (“home run”),

WHEREAS, Ms. Hilton wishes to continue to remain in the public eye without additional scandal and damage to her character, class and persona, whilst continuing to engage in behavior that presents risks to her character, class and persona,

NOW, THEREFORE, the Parties wish to summarize their understandings in this agreement as follows:

1. Partner agrees to not to divulge any Bedroom Secret(s), meaning the whole or any portion of any unusual ability, technique, improvement upon established technique, procedure or position that may be part of Ms. Hilton’s repertoire of methods for bringing, or attempting to bring, Partner to climax. A Bedroom Secret is not limited to a bedroom and may include bathrooms, restaurant kitchens, limousines and PlayStation 2 parties.
2. Partner also agrees to retain and keep private any Confidential Bits, meaning any information, other than Bedroom Secrets, that is known to Partner as a result of their acquaintance and/or sexual congress, but is not generally known to the public, *Us Weekly*, *Star*, “Egplant dike ass” and *Teen People*. Confidential Information includes:
 - i. the nature, scope and description of any piercing, tattoo, birthmark or genitalia possessed by Ms. Hilton, and;
 - ii. special demands or requirements, such as preferred angles of entry, preferred positions, preferred speeds, length of foreplay (if any), duration and quantity of any orgasm(s) and interest levels in the event, and;
 - iii. exclamations, if any, such as, but not limited to “Oh My God!”, “Oh yeah!”, “Oh”, “Ooh”, and “Oooh.”, and;
 - iv. content of any telephone conversations taking place during coitus, and;
 - v. reasons for fornication, including but not limited to: publicity needs, dare, impulsiveness, intoxication, need for attention, loss of moral compass.
3. Partner is forbidden from using any and all recording devices before, during, and after acquaintance and subsequent sexual congress, without express written consent and agreement with Ms. Hilton to split the proceeds.
4. Partner is prohibited from disclosing or permitting any person to hear or read about any Bedroom Secrets or Confidential Bits committed to memory. Partner agrees not to seek financial

gain or notoriety in any form as a result of the event, no matter how awesome Partner believes the event may or may not have been, or how great it would be for Partner's career.

5. The Parties hereto agree that information shall not be deemed a Bedroom Secret or Confidential Bit, if such information:

- i. is already known to the general public, because it appears in *I Night In Paris*.
- ii. is already known to the general public, having been previously divulged by Fred Durst, Nick Carter, Mark Philippoussis, Oscar De La Hoya, Rick Salomon, Leonardo DiCaprio, or any other Class A to Class C celebrities, or;
- iii. is already known to the public, having been contained in her T-Mobile Sidekick, or;
- iv. is leaked, broadcast, e-mailed or otherwise received from an unrelated third party, or;
- v. appears on Fox, or;
- vi. was already mocked by the hilarious Joan Rivers, or;
- vii. is approved for release by authorization of Ms. Hilton's publicist, or;
- viii. is known to have been divulged to fellow convicts and/or prison officials, or;
- ix. is disclosed pursuant to the PATRIOT Act, where disclosure is required by operation of law.

6. Partner agrees not to speak of Ms. Hilton in disparaging terms, including but not limited to: "Skank", "Ho", "Hoskank" and "GG FGT SLT BTCH."

7. Partner understands that any relationship with Ms. Hilton may and probably will taint them to a large portion of the public, with the exception of the intellectually-stunted teenage demographic. Partner understands that such tainting may have negative career and personal ramifications, and that said tainting may be permanent. Partner agrees to indemnify and hold harmless Ms. Hilton regardless.

8. With regard to any legal disputes arising out of or related to this Agreement, Partner agrees that Ms. Hilton enjoys remarkable resilience and is impervious to shame. Partner understands that in all circumstances the prevailing party will be Ms. Hilton.
